### ORDER

As per the GO read as 1<sup>st</sup> paper read above Government have approved the guidelines for the implementation of the Public Education Rejuvenation Campaign. The 8<sup>th</sup> State Level Empowered Committee Meeting held on 28.04.2017 recommended the creation of the following posts for the successful implementation of the Education Mission:

- (1) Three Engineers on deputation / re-employment/contract/working arrangement basis since 1000 schools are to be covered.
- (2) Retain an empanelled agency for architecture consultancy.
- (3) Fourteen posts of District Co-ordinators by deputation/re-employment/contract/working arrangement basis.
- (4) Six Officials with good knowledge of computers and office matters on deputation / re-employment/contract/working arrangement basis.
- (5) Six Officers / Teachers with vision and experience in development initiatives are to be appointed on deputation /working arrangement basis to handle various aspects of the Mission. Ramakrishnan,
- (6) One MIS Expert on contract basis.
- (7) One post of Finance Officer on deputation/ re-employment /working arrangement basis.

In the circumstances Government are pleased to create the said posts for the successful implementation of the Education Mission.
